Dear Deans and Directors,

With the increasing unrest in Hong Kong, Dean Chang-Chuan Chan (Taiwan) has expressed National Taiwan University's willingness to temporarily accommodate exchange students currently in Hong Kong if there is a need to move them due to safety concerns. Additionally, we expressed our support for our new member, the University of Hong Kong MPH Program during these challenging times and remain attentive to the needs of their students, faculty, and staff.

EPA Sign-On Letter Deadline Extended

The Environmental Protection Agency (EPA) is again moving forward with efforts to restrict the science it uses to craft its regulations. The proposal, which is still under review at OMB, would bar EPA from considering studies where the raw research data is not publicly available. This would preclude most human subjects research from informing regulatory policies. ASPPH is circulating a sign-on letter opposing the regulatory proposal. More than half of the deans and program directors have already joined the effort. The deadline for signing-on has been extended to the close of business on Friday (November 22).
